As of April 1, 2018, Ms. Chino is Managing Executive Officer of ITOCHU Corporation (“Itochu”), a Fortune Global 500 company headquartered in Japan, and President & CEO of ITOCHU International Inc., a subsidiary of Itochu in New York. Before assuming her position in New York, she was General Counsel of Itochu. In 2013, she became the first female executive officer of any major trading company in Japan. She is a graduate of Smith College (B.A. cum laude) and Cornell Law School (J.D.), where she serves on the advisory board. She is a classically trained singer and gives solo performances from time to time.
